- Open meeting: Comments
 - Nick: Virtual meetings are set to expire 7/15/2022 - There is state legislation to extend to Dec. 2023, we will see where that goes
 - Nancy: Pride flag on Common (Havoc the dog statue) and removal/relocation of the flag/sign
 - Jessica Spornado - Appreciates work around mission statements, but expected Pride flags around town and surprised not to see them - feels exclusionary. Is this not the purview of the DEI committee?
 - Nick - There are rules/regulations regarding signs/decorations on the Common/municipal land and the Sculpture committee did not have authority to allow the decorations - compromise had to be made
 - Jessica - There should be waiver for this year - SB has the power to waive the rules
 - Flag policy is/will be under review
 - Nikki Kadilak - Suggestion to be proactive to get proper approvals way ahead of time to avoid a similar situation
