- c. Request positive i.d. of seller with name and signature, date of birth and residence of the seller and keep on file at site;
- d. Provide day and hour of purchase;
- e. Record in registry weight and current market value of precious metals or gems;
- f. Registry book will be available for inspection by Police Department at all times.

A violation of any of the terms, conditions or requirements established by the Town of Burlington constitutes grounds for revocation.

4. Applicant agrees that designees of the Burlington Police Department during business hours may enter the premises to ascertain how business is conducted and examine all articles taken in trade or kept or stored at premises and all registry books will be available for inspection by Police Department at all times.

Article XIII Sections 1.27 through 1.28.3/Burlington Bylaws for a License to deal in junk, precious gems and/or metals or secondhand articles for the purchase, sale or barter of such articles, the following definitions apply: Precious metals shall mean any object constructed of or electroplated with Gold, Silver or Platinum, regardless of its form, weight or appearance. The word junk shall refer to "old or scrap copper, brass, rope, rags, batteries, paper, trash, rubber debris, waste, or junked, dismantled, or wrecked automobiles, or parts thereof, iron, steel, and other old or scrap ferrous or nonferrous material" as defined by Chapter 140B, Section 1 of the Massachusetts General Laws, as amended.

Applicant agrees to make out and deliver to the Officer of Criminal Investigation at the Burlington Police Department every business day before 10 o'clock a.m. a correct list containing descriptions and number applied to all articles purchased the preceding business day, the prices paid, time when purchased and photocopy or copy of precious metals and/or gems. (If any items appear as lost or stolen, a "stop order" shall be issued by the Chief of Police or designee) or other arrangements may be made with the department.

6. Applicant agrees to post in a conspicuous place a copy of the Town's Bylaws relating to dealers in junk, precious and/or old metals and secondhand articles;

7. Applicant agrees to provide and maintain a prominent sign indicating name of owner of business and occupation legibly inscribed thereon in large letters at the licensed site.

8. Applicant agrees to not place for display any secondhand items and furniture or effects outside of the premises and will not allow the collection of any refuse rags, old paper and other refuse material.

10. Applicant agrees to not sell any purchased or bartered precious and/or old metals and gems until at least a period of thirty days from the date of its purchase or receipt has elapsed.

11. Applicant agrees to not sell any junk purchased or bartered for at least one week from the date of its purchase or receipt has elapsed. (Secondhand books, prints, coins or postage stamps are exempt.)

Applicant understands that the Burlington Board of Selectmen have the power at all times and at its pleasure to revoke any license granted under this Bylaw and anyone who acts as a dealer for the purchase, sale or barter of junk, precious and/or old metals or secondhand articles without a license, or in any other place or manner than that designated in his license or after notice to him that his license has been revoked, or
